RULES:

- The show will be run according to FCEC Rules.
- All riders are encouraged to wear an approved ATSM helmet however; *all riders under 18 years old must wear a helmet while mounted. Parents/Guardian are responsible to ensure helmet meets standards.*
- The show is open to the public – you do not need to be a FCEC member, however FCEC guidelines will be followed.
- Negative Coggins within twelve (12) months must be provided.
- Show management reserves the right to add, cancel or combine classes.
- When three (3) or less in a class Youth & Adult will be combined.
- FCEC members will be issued back numbers beginning with 8000 and shall be worn by the declared horse/rider combination at all FCEC shows/sanctioned shows. With the exception of any horse/rider combination(s) that have been declared BRHF member would default to the BRHF back number.
- Goodwill and sportsmanship are essential for a fun and safe show, management reserves the right to bar any animal, exhibitor, owner, or spectator for inappropriate behavior.
- Appropriate Show Attire is encouraged (No tank tops, strapless shirts or shorts allowed).
- Neither leadership, or any affiliate of Franklin County Equestrian Club (FCEC) nor any of its members, families, organizers, property owners, nor employees shall be held responsible for accident, damage, injury, illness or loss to the animals, personal property, exhibitors, spectators or any other persons on the show grounds.
- A two (2) minute gate call and five (5) minute tack change will be enforced.
- Membership must be in place before points will accumulate for Year End Awards. For membership information visit: www.franklincountyequestrianclub.com.

- Alcohol is prohibited.
- Stallions must be controlled by an adult at all times.
- **No dogs are allowed.**
- Judges decision is final.

Directions to Shadow Ridge Stables:

From Roanoke, VA:

Take 220 South towards Rocky Mount. Take left onto Wirtz Road/Route 697 (Intersection at Plateau Plaza & Tractor Supply) and continue for approximately 9.2 miles. Take left onto VA-122 North for approximately 4.2 miles. Shadow Ridge Stables will be on your right.

From Rocky Mount, VA:

Take VA-122 North for approximately 10.2 miles. Shadow Ridge Stables will be on your right.

From Bedford, VA:

Take VA-122 for approximately 23.7 miles. Shadow Ridge Stables will be on your left.
