Show Guidelines

- All dogs must be pre-registered to enter show—Fair gate volunteers will have your information and number of dogs attending.
- All dogs must be up to date on Rabies and Bordetello vaccinations.
- Records of vaccination must be mailed in with the entry forms and must have a copy accompany each dog on show day.
- Please bring a copy of your show entry form to show at fair entry gate.
- No aggressive dogs will be allowed to show or enter fair gates.
- No aggressive dogs will be tolerated and will be asked to leave.
- All handlers will need to pay fair entry fee at the gate: Adults \$5.00 under 10—Free
- All dogs must be kept on leash, 6 foot max. leash.
- Dogs are not allowed to walk fair ground area before or after the show, only to enter and leave show. Dogs can not be walking with handler's around food or rides. All dogs will need to leave fair after the end of the show.
- Please bring all the necessary equipment. We will not have provide any water dishes, collars, or leads.
- No unsupervised children, Adults must be present at all times.
- Please dress appropriately, dress shirts and pants, no open toed shoes.

Please read and sign the following statement below: This form must accompany your entry form & vaccination paperwork

I, The exhibitor and guardian of the minor, have read all the rules and regulations, and consent to follow all said rules and regulations. Failure to follow all rules and regulations will result in expulsion from this show and all future shows sponsored by the Franklin County Agricultural Fair.
